LAMMICO RISK MANAGEMENT PROCEDURAL RULES

1. To register for a webinar, log in as a Member at lammico.com/login and select “Webinars” from the drop-down menu under your name if you are using a desktop or laptop computer or tablet.
2. Join the webinar using the link that will be emailed to you upon registration. You will also receive a reminder email the day before with the link to join.
3. Once signed into the webinar, your time will be monitored by the webinar system.
4. CME/CNE certificates will be created based upon the time the participant remains in the session. For example, if the program was one hour but the participant left after the first 40 minutes, a certificate for 0.75 credits will be issued.
